IMPORTANT SAFETY INSTRUCTIONS

- 1. Read and keep this instruction sheet for future reference.
- Please note that all fixed wiring appliances should be installed by a qualified electrician.
- 3. The supply to the receiver should be connected on its own circuit.
- 4. Switch off the power at the circuit breaker before working on receiver or ceiling fan.
- 5. This unit is to be used for the control of a ceiling fan and its electrical source must be AC 110/120V, 60Hz.
- 6. Do not install in damp location or immerse into water. For indoor use only.
- 7. Do not use this remote with fans that have pre-installed remote controls.

CAUTION: To reduce the risk of fire or injury, do not use this product in conjunction with any variable (rheostat) wall control.

RECEIVER INSTALLATION INSTRUCTIONS

NOTE: This remote can work with a variety of hugger fan types, however, there is typically very little space in the hanger bracket area to install a receiver. Therefore, we do not recommend using this remote with hugger type or 5 speed ceiling fans.

- 1. After switching power off @ circuit breaker, remove ceiling fan canopy from the mounting bracket. Disconnect existing wiring between ceiling fan and supply at electrical junction box.
- Slide the receiver into the mounting bracket per FIG.1 being careful not to pinch the antenna wire.
- 3. The receiver will be inserted between the down rod and the mounting bracket.
- 4. Make wiring connections per FIG. 2.
- Push all connected wires back into the junction box and reinstall the canopy onto the mounting bracket.
- 6. Manually set fan speed control to HIGH and set light to ON using the pull chains.

NOTE: For the remote to function properly, the fan must be on HIGH speed and lights must be ON to use.

CAUTION: Incorrect wire connection can damage this receiver and could cause injury or fire.

ACTIVATING THE LEARNING PROCESS (SMART SYNC)

NOTE: This remote is pre-programmed from the factory and should work right out of the box once the battery is installed. Should, for any reason, re-programming be needed please follow the learning process as follows:

1. After installation is complete and power is turned on, remove the battery cover on transmitter. Insert batteries (4 AAA, included).

NOTE: Do not mix old and new batteries, alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium) batteries.

- 2. Use a small screwdriver or ballpoint pen to press and hold the "LEARN" key, located in the battery compartment (see FIG. 3.), for 3 seconds. Fan will turn on at high speed and light (if installed) blinks 3 times. This confirms that the SMART SYNC setting is active. You now have 30 seconds to press the LEARN key. Tap the FAN OFF button to turn off the fan.
- 3. If user cannot finish the setting within the 30 seconds time frame the main power must be turned off and re-started again. This will reset the unit. Repeat step 2 until the LEARNING feature is activated as indicated.

NOTE: User must press "LEARN" key <u>within 30 seconds</u> after main power is turned on. It is not necessary to redo the LEARNING setting if just replacing batteries.

DIMMER ON/OFF SETTING (D/O SWITCH)

Slide the D/O switch, located in the battery compartment (See FIG. 3), to match the bulb type in your fan. "D" is for incandescent bulbs and "O" indicates compact fluorescent

bulbs (CFL). Use a small screwdriver or ballpoint pen to slide firmly left or right.

CAUTION: Incorrect bulb setting can damage the receiver.




INTO CANOPY ASSEMBLY





TRANSMITTER OPERATION (FIG.4)

High / Medium / Low Speed – Tap lightly to turn the fan on at high, medium or low speed respectively.

Fan Off - Tap lightly to turn the fan off.

Light –Tap lightly to turn light on or off. Hold down for 2 seconds to cycle through dimmer setting. The light button has an auto resume feature so the light will re-activate at the same brightness as the last time it was turned off.

NOTE: The dimmer function does not work with CFL bulbs.

Walk Away Light Delay – Tap once - the light and fan turn off after 1 minute. Light on the fan blinks once to confirm function is active. Press any button to cancel function.

Home Shield – Press and hold the Light and Delay buttons for 3 seconds. Light on the fan blinks two times to confirm function is active. Fan will be off and the light will randomly turn on and off while you are away. To deactivate press any button once.

D/O – Set the light for use with incandescent bulbs or compact fluorescent bulbs (CFL).

LEARN – Synchronizes transmitter and receiver signals.

NOTE: Factory default setting is CFL.

INSTALLING THE MAG MOUNT BRACKET

- 1. Locate wall mount in a convenient location
- 2. Use two screws (included) and wall anchors to install rear plate as shown in FIG. 5. (Tools required for assembly: Philips screwdriver, not included)
- 3. Position front plate over rear plate.

TROUBLE SHOOTING

- Review receiver wiring is it wired correctly and receiving power?
- Is the fan speed control on HI and light switch in the ON position?
- Are all four batteries new and fully charged?
- Learning process between fan and transmitter may not have been successful see step 2 under activating the learning process
- Won't operate at a distance make sure antenna wire is visible and not obstructed



TRANSMITTER OPERATION


